15 **STIPULATED SURRENDER AND**
16 **DISCIPLINARY ORDER**

17 The Bureau disciplined Kenneth Bryan's real estate appraiser license effective
18 September 22, 2017. The disciplinary order suspended Mr. Bryan's license, but the suspension
19 was stayed and Mr. Bryan's license publically reprovved and monitored on probation for three (3)
20 years on terms and conditions. Mr. Bryan is still on probation. The terms and conditions of
21 probation include an option for Mr. Bryan to surrender his license. Mr. Bryan is requesting to
22 surrender his license with this Stipulated Surrender of License and Order (Stipulated Surrender).
23 The Chief of the Bureau of Real Estate Appraisers (Bureau Chief) will now evaluate Mr. Bryan's
24 request and decide whether to grant the request.

25 **PARTIES**

26 On or about September 17, 2004, the Bureau issued Mr. Bryan Real Estate Appraiser
27 License Number 035160. Mr. Bryan's License was suspended on September 26, 2018, for failure
28 to complete education as a term of probation.

ADVISEMENT AND WAIVERS

Mr. Bryan has carefully read and understands this document and the consequences of
surrendering his license and the effects of this Stipulated Surrender. Mr. Bryan is fully aware of
his legal rights in this matter, including his right to obtain legal counsel at his own expense. Mr.
Bryan voluntarily, knowingly, and intelligently waives his right to counsel.

1 CONTINGENCY

2 This Stipulated Surrender is subject to approval by the Bureau Chief.

3 Portable Document Format ("PDF") or facsimile copies of this Stipulated Surrender,
4 including PDF or facsimile signatures thereto, shall have the same force and effect as the
5 originals.

6 This Stipulated Surrender is intended to be a complete and integrated writing. It supersedes
7 any and all prior or contemporaneous agreements, understandings, discussions, negotiations, and
8 commitments (written or oral) by anyone at the Bureau and Mr. Bryan. This Stipulated Surrender
9 may not be altered, amended, modified, supplemented, or otherwise changed except by a writing
10 executed by an authorized representative of Mr. Bryan and the Bureau Chief.

11 The Bureau Chief may, without further notice or formal proceeding, issue and enter the
12 following Order:

13 ORDER

14 IT IS HEREBY ORDERED that Mr. Bryan's Real Estate Appraisers License No. 035160 is
15 surrendered and accepted by the Bureau Chief.

16 1. Mr. Bryan shall lose all rights and privileges as a real estate appraiser in California as
17 of the effective date of the Chief's Decision and Order.

18 2. Surrender of Mr. Bryan license shall be considered a disciplinary action and become a
19 part of his license history with the Bureau.

20 3. Mr. Bryan may petition for reinstatement of his license no sooner than one year from
21 the effective date of the Decision and Order. If Mr. Bryan petitions for reinstatement, the Chief
22 shall treat it as a new application for licensure and Mr. Bryan must comply with all the laws,
23 regulations and procedures for licensure in effect at the time the petition is filed.

24 4. The Bureau's August 23, 2017, Order directed Mr. Bryan to pay the Bureau Three
25 Thousand Dollars (\$3,000). Mr. Bryan shall continue to make payments as directed in the August
26 23, 2017 Order until the entire amount is paid.
